

General conditions of participation

With the registration the following conditions are accepted:

1. registration

Registration for events must always be made in writing, using the registration form. The following personal data will be collected: Title, title, first and last name, company, address, position and interests. Registrations are regularly considered in the order in which they are received; special selection procedures for specific events remain unaffected. The registration will be confirmed at the latest after the registration deadline. The contract is concluded upon receipt of the confirmation.

2. terms of payment

The following applies to events for which a fee is charged: Unless other payment arrangements have been agreed, payment is due upon receipt of the registration for the event. If a different date is stated in the invoice, this date shall apply. In the event of late payment, bwcon may exclude participants from participation. After receipt of payment, participants will receive a booking confirmation. The costs for participation can be found in the registration information for the respective event.

3. withdrawal and termination

In the case of events, the contractual partner may withdraw from the contract if he/she notifies the withdrawal in writing at least seven working days before the start of the event. If the withdrawal is not made in due time, the contractual partner is obliged to pay the full fee. The provision of a substitute participant is possible at any time.

The date of receipt of the withdrawal notice is decisive. Please send your notice of withdrawal by email to events@bwcon.de.

4. cancellation / changes of events

Baden-Württemberg: Connected e.V./bwcon GmbH/ bwcon research gGmbH, hfcon GmbH & Co KG, hfcon Verwaltungs GmbH reserves the right to cancel events up to one day before the start of the event, especially in case of insufficient registrations. Any further claim for damages is excluded. This also applies in the case of cancellations at short notice or a cancellation of the event, even if prior notification of the participants should no longer be possible. Insofar as the event is not significantly impaired, the change of speakers and postponements in the schedule do not entitle the participants to withdraw from the contract or to reduce the fee. In the event of cancellation of the event due to force majeure (fire, strike, terrorism, etc.) or other circumstances for which Baden-Württemberg: Connected e.V./bwcon GmbH/ bwcon research gGmbH, hfcon GmbH & Co KG, hfcon Verwaltungs GmbH is not responsible, but which affect the services of Baden-Württemberg: Connected e.V./bwcon GmbH/ bwcon research gGmbH, hfcon GmbH & Co KG, hfcon Verwaltungs GmbH, the participant is not entitled to a refund of the participation fee or to compensation for other damages, such as travel or hotel costs. In the event of force majeure, Baden-Württemberg: Connected e.V./bwcon GmbH/ bwcon research gGmbH, hfcon GmbH & Co KG, hfcon Verwaltungs GmbH shall be exempt from performance for the duration of the hindrance.

5. data protection
